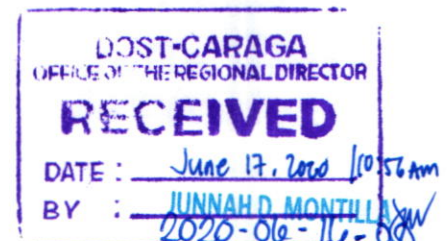

### RESOLUTION EXPRESSING HEARTFELT GRATITUDE AND COMMENDATION TO ALL PRIVATE COMPANIES, CIVIC GROUPS, PRIVATE INDIVIDUALS AND GOVERNMENT AGENCIES FOR THEIR FINANCIAL SUPPORT AND IN-KIND DONATIONS EXTENDED TO THE PROVINCE OF AGUSAN DEL NORTE DURING THE COMMUNITY QUARANTINE BROUGHT ABOUT BY THE CORONA VIRUS DISEASE 2019 (COVID-19) PANDEMIC

**WHEREAS**, the World Health Organization (WHO) in March 2020 declared the Corona Virus Disease 2019 (COVID-19) as pandemic since it has claimed the lives of more than three hundred forty thousand (347,000) people and with more than five million five hundred thousand (5,500,000) cases since its outbreak in January 2020;

**WHEREAS**, President Rodrigo R. Duterte issued Proclamation No. 922 on March 9, 2020, declaring State of Public Health emergency throughout the Philippines and the Code Alert System for COVID-19 was raised to Code Red Sub-Level 2 in accordance with the recommendation of the Department of Health (DOH) and the Inter-Agency Task Force for Emerging Infectious Diseases (IATF-EID), and further issued Presidential Proclamation No. 929, series of 2020, declaring a State of Calamity in the country due to COVID-19;
