KNOW ALL MEN BY THESE PRESENTS:

This AGREEMENT made and entered into this 28th day of February 2020 by and between:

The **DEPARTMENT OF SCIENCE AND TECHNOLOGY**, Region 13, a government agency with office address at CSU Campus, Ampayon, Butuan City, herein represented by **MS. DOMINGA D. MALLONGA**, Regional Director, hereinafter referred to as the **PARTY OF THE FIRST PART**;

and

FELIX REF. AND AIRCON SERVICES, an institution duly registered and licensed aircon maintenance services with postal address at 145, Langihan Road, Btuan City represented by **FELIX A. BENOLIRAO**, Proprietor, hereinafter referred to as the **PARTY OF THE SECOND PART**;

TERMS AND CONDITIONS

1. The PARTY OF THE FIRST PART desires to engage the labor services for maintenance and repair of aircon units by the PARTY OF THE SECOND PART and shall perform the following:

2. That the PARTY OF THE SECOND PART shall conduct check-up activities monthly or as deemed necessary; and conduct of clean-up will be once every quarter for all types of air conditioning units for the period March 15 to December 31, 2020.
3. Payment shall be made within ten (10) working days from date of receipt of billing thereof.
4. Amount payable shall be subject to withholding tax and such other taxes that may be deemed due.
5. In case of breakdown/malfunction, the PARTY OF THE SECOND PART shall repair/provide maintenance personnel within twenty-four (24) hours upon request/after call-up.

6. The PARTY OF THE SECOND PART shall be accountable for any breakdown or malfunction of the maintained units due to negligence and inattention of the maintenance personnel.
7. That either PARTIES may rescind this Contract upon notice to each party anytime a PARTY fails to comply any of the provisions of this contract.
8. That both PARTIES warrant the faithful compliance of the foregoing terms and conditions of the contract.
9. That after expiration of this contract and no new contract has been made or issued by the Entity or that the result of the bidding is not yet issued, if one is conducted, this contract shall be deemed extended on a month to month basis up to such period as may allowed by law, rules and regulations.
10. In case of litigation for any breach, claim for damages, acts or omissions giving rise to legal actions, the PARTIES agree that the venue of such action shall be at any court setting in Butuan City.





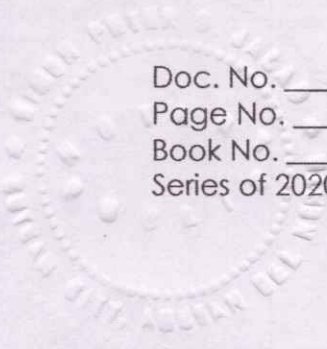
