Supply, Delivery, and Installation of Equipment in Developing SMART Community in Talacogon thru S&T Intervention for R&D on Arenga Pinnata Products; Disaster Risk Resiliency; and Education Component

1. The *DEPARTMENT OF SCIENCE AND TECHNOLOGY-CARAGA*, through the *General Appropriations Act 2022* intends to apply the sum of:
 - *Eight Hundred Thirty-Eight Thousand Pesos Only (P838,000.00)* for **LOT No. 1 – Equipment for R&D on Arenga Pinnata**
 - *Four Hundred Fifty Thousand Pesos Only (P450,000.00)* for **LOT No. 2 – Starbooks**
 - *Three Hundred Fifty-Seven Thousand Pesos Only (P357,000.00)* for **LOT No. 3 – Water Level Monitoring Station (WMLS)**being the ABC to various payments under the contract for each lot/item. Bids received in excess of the ABC for each lot/item shall be automatically rejected at bid opening.
2. The *DEPARTMENT OF SCIENCE AND TECHNOLOGY-CARAGA* now invites bids for the above Procurement Project. Delivery of the Goods is required ***within 90 days upon receipt of Notice to Proceed***. Bidders should have completed, within ***two (2) years*** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”. Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.
4. Prospective Bidders may obtain further information from the *DEPARTMENT OF SCIENCE AND TECHNOLOGY-CARAGA* and inspect the Bidding Documents at the address given below during ***8:00 A.M. to 5:00 P.M.***
5. A complete set of Bidding Documents may be acquired by interested Bidders on ***May 12, 2022 to June 1, 2022*** the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of:
 - Lot No. 1 - P800.00
 - Lot No. 2 - P500.00
 - Lot No. 3 - P500.00
 - Lot Nos. 1 to 3 - P1,600.00

The Procuring Entity shall allow the bidder to present its proof of payment for the fees *in person, by facsimile, or through electronic means.*

6. The *DEPARTMENT OF SCIENCE AND TECHNOLOGY-CARAGA* will hold a Pre-Bid Conference¹ on **May 20, 2022 @ 1:30 P.M.** at *DOST Caraga Conference Room, CSU Campus, Ampayon, Butuan City* through video conferencing or webcasting via *zoom or google meet* which shall be open to prospective bidders.
7. Bids must be duly received on **June 1, 2022 @ 1:00 P.M.** by the BAC Secretariat through manual submission at the office address indicated below. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **June 1, 2022 @ 1:30 P.M.** at ***DOST Caraga Conference Room, CSU Campus, Ampayon, Butuan City*** via videoconferencing. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The *DEPARTMENT OF SCIENCE AND TECHNOLOGY-CARAGA* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
